

1.	To pay the requested fees by the date specified on the invoice (payment days are Tuesday and Thursday) as outlined in the Instrumental Music handbook. I understand my child will NOT receive lessons (beyond the first one) until the applicable fees are paid. I acknowledge that this fee is non-refundable except in the case of prolonged absence for medical reasons. (A payment plan can be arranged if necessary – please speak to office staff about this).
2.	To <u>provide all the necessary equipment</u> required (pre-requisites) as outlined in the Instrumental Music Handbook including books, a music stand and other accessories specific to my child's instrument. These are required for their first lesson.
3.	To <u>ensure that my child is present</u> at all performances and rehearsals (Band rehearsal will be before school at 7.50am – please do not accept a place if your child cannot attend.) I will provide a note or email if my child is absent.
4.	To encourage my child to utilise the program through practice and by taking an interested and active role in their instrumental development and progress.
5.	To keep my child actively enrolled in the IM program for the FULL YEAR to maximise learning opportunities.
6.	To <u>provide an instrument for my child</u> as indicated above. (Many will not require this until their second year of playing)
